VOTER INFORMATION AND INSTRUCTIONS

A general election is scheduled to be held in Panoche Water District on November 8, 2022, for the office of Director. You are receiving this Voter's Pamphlet and the enclosed materials because records indicate that you are a landowner in the District and are entitled to vote in this General Election. There are two director positions to be filled that will serve through December 7, 2026. You may vote for two candidate(s).

This is an ALL-MAIL BALLOT election. There will be no polling places designated. You must VOTE USING THE ENCLOSED OFFICIAL BALLOT and return it by mail or deliver it to Panoche Water District, using the Identification/Return Envelope provided.

Either:

(1) mail your voted ballot in the postage paid Identification/Return Envelope early enough for the Post Office (or, if you decide to use a bona fide private mail delivery company, for that company) to deliver it by TUESDAY, NOVEMBER 8, 2022; or (2) hand deliver your voted ballot in the Identification/Return Envelope to the District's office located at 52027 West Althea Ave., Firebaugh, CA 93622 before 8:00 P.M. on

TUESDAY, NOVEMBER 8, 2022. Any vote by mail ballot shall be timely cast if (1) it is received by the District via United States Postal Service or a bona fide private mail delivery company no later than 3 days after election day *if theballot is postmarked on or before election day*, or (2) it is time stamped or date stamped by a bona fide private mail delivery company, on or before election day. Do not fax or email your ballot.

HOW TO VOTE AND RETURN YOUR BALLOT

IMPORTANT: Be sure you are the authorized voter. The authorized voter is the natural person or entity named on the first line of the voter address on the ballot and the label on the Identification/Return Envelope.

<u>AUTHORIZATION TO VOTE</u>: If the landowner is <u>not</u> a natural person (for example, if the landowner is a corporation, partnership, or trust), title to the land is held as community property, as a joint tenancy or tenants in common, or title is held by an estate, guardianship, or conservatorship, please either: (a) ensure that each line on the "Authorization To Vote" form is completed before the form is placed with the Official Ballot inside the Identification/Return Envelope, or (b) ensure that alternative documentation (for example, a corporate resolution or trust document) authorizing a natural person to vote for the landowner is placed with the OfficialBallot inside the Identification/Return Envelope.

<u>APPOINTMENT OF PROXY</u>: If the landowner seeks to appoint a proxy, please ensure that each line on the "Appointment of Proxy" form is completed before the form is placed with the Official Ballot inside the Identification/Return Envelope.

Failure to properly establish authorization to vote or to complete an Appointment of Proxy form may result in the ballot being rejected and the votes not counted for the subject election.

- 1. Follow the INSTRUCTIONS TO VOTERS in the Official Ballot to mark/vote your ballot.
- 2. Detach the top portion from the ballot as indicated on the ballot. This is your receipt for voting.
- 3. Place the marked ballot inside the matching Identification/Return Envelope: **ONE VOTED BALLOT PER ENVELOPE.** If you are voting and returning multiple ballots, the number printed on the ballot must match the number printed on the return address label of the Identification/Return Envelope.
- 4. If required, enclose the Authorization to Vote form/alternative documentation and/or Appointment of Proxy form (forms have been provided as an insert in the Voter's Pamphlet) in the Identification/Return Envelope. Instructions for establishing authorization to vote and the appointment of proxy are included in this Voter's Pamphlet.
- 5. Fold the flap of the envelope over to seal the Identification/Return Envelope.

- 6. Fill in the complete mailing address, the date and place of signing and <u>sign</u> the <u>declaration on the Identification/Return Envelope</u>.
- 7. Return postage has been prepaid. Your Official Ballot may be returned by other means, including by a bona fide private mail delivery company or hand delivered to the District office, if you wish.

AUTHORIZATION TO VOTE FORM/ALTERNATIVE DOCUMENTATION

Many landowners are required to file the *AUTHORIZATION TO VOTE FORM* or OTHER DOCUMENTATION DESIGNATING THE AUTHORIZED INDIVIDUAL TO VOTE.

If the landowner is not a natural person (such as partnership, corporation, association, trust), title to the land is held as community property, as a joint tenancy or tenants in common, or is held by an estate, guardianship, or conservatorship, then the landowner must return either (1) a completed *AUTHORIZATION TO VOTE FORM* (a copy of which has been provided as an insert in the Voter's Pamphlet) or (2) other documentation authorizing a natural person to vote for the landowner.

Please follow the instructions provided on the AUTHORIZATION TO VOTE/APPOINTMENT OF PROXY insert.

If you are already identified as an individual trustee, you do not need to fill out any additional paperwork.

APPOINTMENT OF PROXY FORM

If you intend to vote by proxy, you must complete the *APPOINTMENT OF PROXY FORM* (a copy of which has been provided as an insert in the Voter's Pamphlet).

Please follow the instructions provided on the AUTHORIZATION TO VOTE/APPOINTMENT OF PROXY insert.

FOR AUTHORIZATION TO VOTE OR APPOINTMENT OF PROXY

Please remember:

If an authorization to vote is required or if you intend to appoint a proxy, you must return an AUTHORIZATION TO VOTE FORM/ALTERNATIVE DOCUMENTATION or APPOINTMENT OF PROXY FORM to the District prior to the election or with the Official Ballot in the Identification/Return Envelope.

Use care when returning ballots. A fully legible signature is required to match the ballot and only the person who is listed on the first line of the ballot, or the duly authorized representative or proxy thereof, may sign and execute the Identification/Return Envelope. If an authorization to vote or a proxy has been granted by the Landowner, then the person authorized to vote for the landowner or the appointed proxy must sign the Identification/Return Envelope.

IMPORTANT: FAILURE TO RETURN AN AUTHORIZATION TO VOTE FORM/ ALTERNATIVE DOCUMENTATION OR AN APPOINTMENT OF PROXY FORM MAY RESULT IN THE BALLOT BEING REJECTED AND THE VOTE(S) NOT COUNTED FOR THE SUBJECT ELECTION.

- 3. **AUTHORIZATION TO VOTE**: If the landowner is not a natural person (for example, if the landowner is a corporation, partnership, or trust), please either: (a) ensure that each line on the "Authorization To Vote" form is completed before the form is placed with the Official Ballot inside the Identification/Return Envelope, or (b) ensure that alternative documentation (for example, a corporate resolution or trust document) authorizing a natural person to vote for the landowner is placed with the Official Ballot inside the Identification/Return Envelope.
- 4. **APPOINTMENT OF PROXY**: If the landowner seeks to appoint a proxy, please ensure that each line on the "Appointment of Proxy" form is completed before the form is placed with the Official Ballot inside the Identification/Return Envelope. **NOTE:** *Unless previously provided to the Election Official for this election*, an "Authorization to Vote" form/alternative document and/or "Appointment of Proxy" form must be completed and placed with the Official Ballot inside the Identification/Return Envelope.
